A dual membership is defined as two adults living in the same household. A single parent shall only be charged the cost of 1 Adult member. Any family member under 21 years of age will be allowed to participate in FSWC activities under the membership of the Adult family member/members. If you would like family members under 21 years of age listed in the Membership Directory (with photo), please inform Dennis Gallagher, VP Membership, when you submit your application, providing the name (and photo).

Also, to be included in the FWSC annual Directory, former members must renew their membership no later than November 2, 2024.

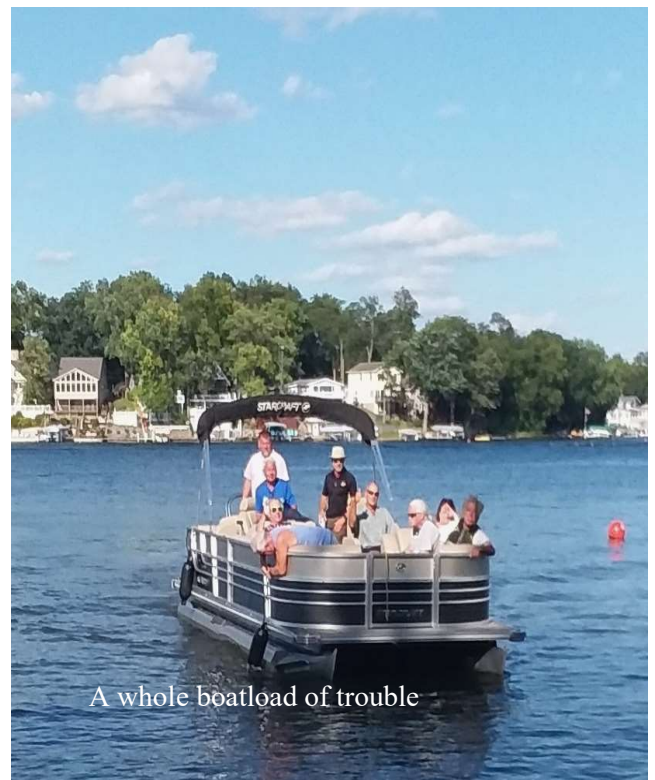
